

P&J Live Rigging

Standard Point (Drop Wires and Lifting Points) - Where the point of attachment to the lifting assembly is directly below a structural beam to be used for lifting. Our standard point cost includes the equipment to create the point, our riggers to install it, and our use of access equipment.

Off Beam Point (Drop Wires and Lifting Points) - Where the point of attachment to the lifting assembly is not directly below a structural beam to be used for lifting. The extra equipment, design, and time involved in installing these points mean that they incur a 50% surcharge per point.

Please note Drop Wires are not to be used as hoisting points.

Chain and Motorised Hoists

Hoists will be priced on application to the venue. There will be a charge for the venue to connect client's hoists to lifting points. Client hoists must be supplied with all relevant documentation. Please see Terms and conditions.

PVC/Fabric Banner Rigging - The venue offers the above packages for the rigging of PVC and Fabric Banners where banners are freighted to site directly to be hung before show build-up date. Banners not freighted before the build-up date will be charged at standard rates. Banners should be constructed with an 80mm pocket at top and bottom. A deadline for banner delivery will be provided on application and will usually be a minimum of 2 days prior to the beginning of the show tenancy to allow rigging before stand arrival. The venue will not pay to return the banner to the client. Any banner incorporating a frame or other complex/unusual style of construction will be provided a price on application.

Trussing - Where required the venue will provide a price on application for both the supply and or lifting of truss assemblies. Where trussing is provided by the client each piece of equipment, must be of suitable design and have the associated certificate of conformity alongside current certificate of thorough examination. Any equipment without relevant documentation will not be flown on the P&J Live site. The venue will only supply labour for the lifting and fixing of client truss and not construction.

Lighting - Where required the venue will provide a price on application for the supply and or rigging of bespoke lighting packages. Power for lighting requirements will not be included in this price and will require application to either the event organiser or the venue electrical department.

Price on Application – P&J Live issues bespoke quotes for all complex rigging projects. To receive a quote, we require a rigging plan that details your rigging point positions and weight loadings. We will then be able to assess for you how many rigging points can be achieved from standard points and how many will need to be created. Once we issue a quote, we will require a purchase order number to confirm your order.

OE 25 Restrictions

Hall 1 Aisles A to R – Where your stand is situated on aisles A to R, the maximum height for flown assemblies is 7m with a maximum build height of 6m. **Please contact Rigging@pandjlive.com for stand specific recommendations**

Hall 1 Aisles S to X - Where your stand is situated on Aisles S to X, further rigging restrictions may apply. 4m max build height for stands in this area. **Where stands are built to maximum height the ability to rig above the stand will be reduced.** **Please contact Rigging@pandjlive.com for stand specific recommendations.**

Hall 2 – 7m maximum rigging height for flown assemblies with a maximum build height of 6m. **Please note stands situated on aisles A and F may encounter high level obstructions reducing maximum height of flown assemblies to 6m.** **Please contact Rigging@pandjlive.com for stand specific recommendations.**

Hall 3 – 12m max height for flown assemblies with a maximum build height of 6m. **Please contact Rigging@pandjlive.com for stand specific recommendations.**
